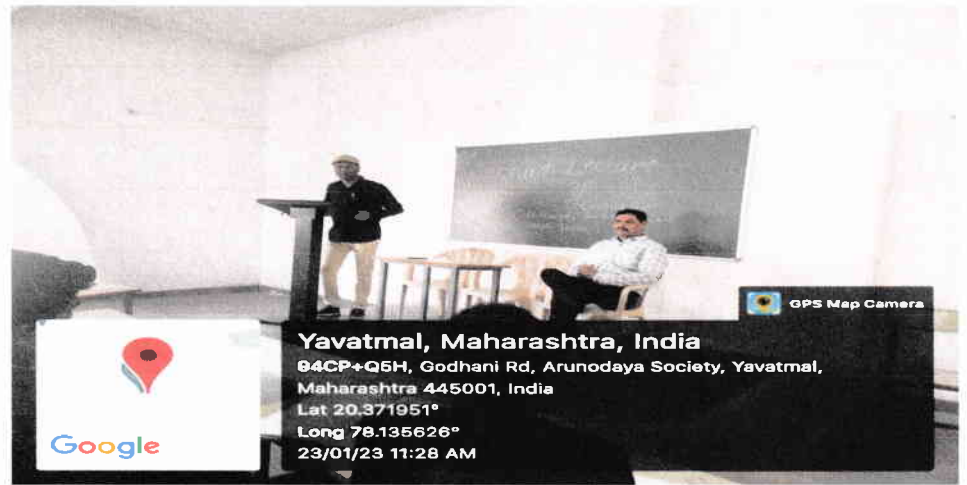
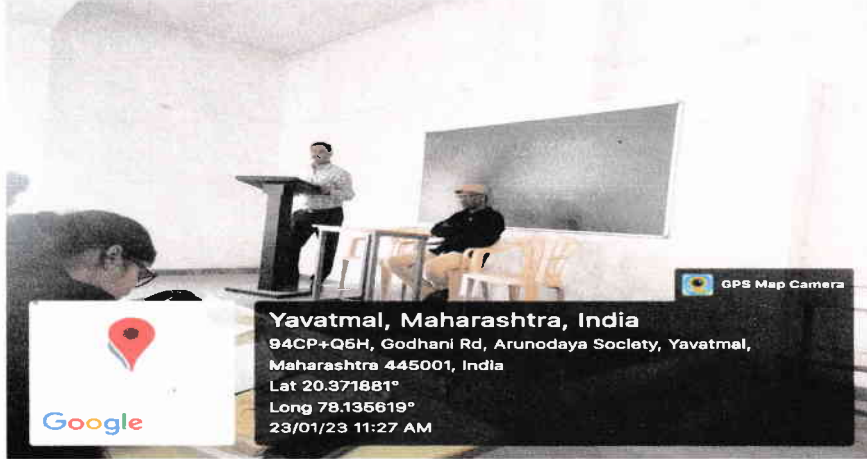

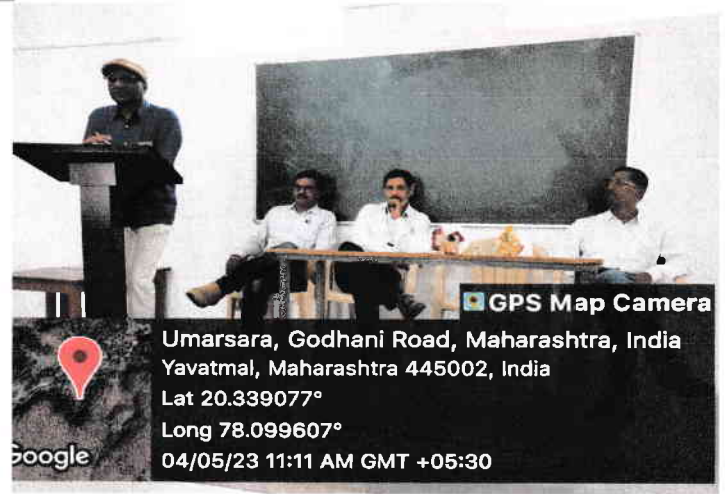

The PARTY OF THE SECOND PART i.e. the said College hereby agrees and acknowledges that at all times the material provided to them shall be sole property of the PARTY OF THE FIRST PART and the same shall not be misused by the PARTY OF THE SECOND PART or its researchers, staff or students etc. In event of any misuse of the material so provided, the PARTY OF THE SECOND PART shall be solely responsible for the same.

- iii) Natural calamities such as floods, earthquake etc.







**Objectives:**

The Parties will convene joint consultative meetings at such intervals, at the location, and by the methods, they deem appropriate. At such meetings they will consider ways and means of improving mutual cooperation, prepare work programs, as appropriate, and review progress in the cooperation activities carried out under the MoU, adjusting them as necessary.

The Parties may, through a simple exchange of correspondence, agree to carry out, if need be, some specific activity not included in the work programme, including exchange of Faculty and Staff for educative and Administrative engagements.

The Parties will co-operate and organize jointly the various activities like Eco friendly Activities, Personality Development Programme, Anti-sexual harassment activities, RTI related programme.

The Parties may indulge in organizing Online/ offline Conference, Seminar, Workshop, Short Term Courses, Certificate Courses, Guest Lectures on the legal issues as well as the topic of importance of general nature etc.

#### **Financial Obligations**

Financial obligations in carrying out the role delineated in this MoU will be determined by the Parties through mutual consultation and formal agreement on a case by case basis, in accordance with the rules, regulations and procedures of each Party. This MoU does not impose any financial obligation on either Party in the absence of a separate formal agreement.

#### **Commencement, Duration and Termination**

This MoU will come into effect upon the date of its signature by both Parties hereto. This MoU may be terminated by either of the Parties upon written notice to the other Party and will terminate 60 days after receipt of such notice.

#### **Amendment**

The terms and conditions of this MoU may be changed only by mutually agreed and accepted written amendments signed by both signatories, which will be annexed to this MoU, of which they will form an integral part.

#### **Channel of Communication and Notice**


Any notice to be given to either Party with respect to this MoU will be considered as effectively given, if delivered or sent by letter through post or by email or by fax. Any such notice will become effective on the day of its receipt by the Party to which it is addressed. The address of either Party may be changed by appropriate notice to the other Party.

#### **Arbitration Clause**

Any dispute arising out of this MoU will be settled by mutual negotiations between the two Parties. Ramkrishnaji rathi Law College, Washim.


